The tender documents written in English may be obtained From Rwanda Meteorology Agency starting from Arth/April 2017, from 7:00AM local time to 5:00PM local time on working days, by presentation of a payment slip of a non-refundable fees of Ten thousand (10,000) Rwandan Francs deposited to the account non fiscal revenues N°1000003777/ RRA of Rwanda revenue Authority opened at National Bank of Rwanda (BNR) or any bank where RRA has an account for that purpose.
- 4. The bids shall be accompanied by a bid security of Three hundred and sixty thousand Rwandan Francs (360,000Rwf) only issued by a reputable Bank or a registered insurance company.

Well printed bids Written in English language, properly bound and presented in four copies one of which is the original must be submitted to the Rwanda Meteororlogy Agency, procurement office, room 001 at the adress mentioned above, not later than Add May 2017 at 10:00 AM local time(8:00AM GMT). Late bids shall be returned unopened and bids sent electronically shall not be accepted.
- Bids will be opened in the presence of bidders or their representative who choose to attend on the same day at Rwanda Meteororlogy Agency, The procurement office, room 001, on 2014 May 2017 at 10:30 AM local time(8:30 AM GMT), The outer envelope should clearly indicate title and tender reference Number.

Bidding will be conducted through the National open competitive Bidding (NOCB) procedures specified in law n°05/2013 of 13./02/2013 modifying and completing the law n° 12/2007 of 27/03/2007 on public procurement and ministerial order no 001/14/10/TC of 19/02/2014 establishing regulations on public procurement, standard bidding documents and standard contracts. Participation is open on equal conditions to all specialized companies.
