2. METEORWANDA invites qualified bidders to submit bids for Supply and install ICT equipments

Tender Documents in English may be obtained from the procurement Office, room No 001, in METEO RWANDA upon presentation of proof of payment of a non-refundable fee of ten thousand Rwandan Francs (10,000 Frw) to Account N° 120.00.46 of RRA opened at National Bank of Rwanda (BNR) or in any bank where RRA has open an account for this purpose.
- 4. Tender Documents may be obtained on any working day from the Procurement Office at Rwanda Meteorology Agency headquarters from .23. May 2017
- **5.** All bids *must* be accompanied by a Bid security of one million Rwandan Francs(**1000,000Rwf**). Only issued by a reputable Bank or a registered insurance company.
- 6. Well printed bids, properly bound and presented in four copies one of which is the original must reach Meteo Rwanda, Procurement Office at the address mentioned above not later than June 2017 at 10:00 am local time. Late bids will be rejected and electronic bids are not allowed.
- 7. Bids will be opened in the presence of bidders or their representatives who choose to attend at Meteo Rwanda headquarters situated at Gitega, Nyarugenge District, and Procurement Office on 23. June 2017 at 10:30 am Local time. The Outer envelope should clearly indicate the tender reference number and title.
- **9.** Bidding will be conducted through the National open Competitive Bidding (NOCB) procedures specified in *law* $n^{\circ}05/2013$ of 13/02/2013 modifying and completing the law $n^{\circ}12/2007$ of 27/03/2007 on public procurement and ministerial order $n^{\circ}001/14/10/TC$ of 19/02/2014 establishing regulations on public procurement, standard bidding documents and standard contracts. participation is open on equal conditions to all specialized companies
